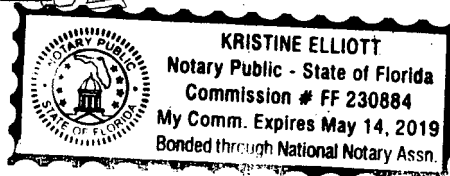

AMENDMENT TO
DECLARATION OF AMENDED COVENANTS AND RESTRICTIONS
FOR MUIRHEAD ESTATES AT ABERDEEN

(additions indicated by underlining, deletions by "~~strikethroughs~~" and unaffected language by ". . ." or "***")

Amendment to Article 15, Section 15.2.1 of the Declaration of Amended Covenants and Restrictions for Muirhead Estates at Aberdeen ("Declaration"), as follows

ARTICLE 15
GENERAL PROVISIONS

15.1 Amendment. This Declaration may be amended from time to time by recording among the Public Records of the County any instrument executed by the President and attested to by the Secretary of the Association, indicating (if required pursuant to the terms hereof) that a meeting called for purposes of amendment was held, and that the requisite number of Members formally approved the amendment, subject, however, to the following provisions:

15.2.1 Except as provided hereinbelow, an amendment initiated by any party must obtain the approval of at least a majority ~~66 and 2/3rds percent (66 2/3%)~~ of the votes of Members.
